

**TERMS AND CONDITIONS  
FOR DORICO EXTENDED TRIAL BY YAMAHA PROMOTION**

**ARTICLE 1 – DEFINITIONS AND INTERPRETATIONS**

<b>"Authorized Dealer"</b>	A dealer officially authorized by the Promoter.
<b>"Product Reward"</b>	A free extended trial period of Steinberg's notation software "Dorico" (Participant will have access to 120 days trial period) that a Participant is entitled to when purchasing a Promotion Product in accordance with these terms, and as set out in Schedule 1.
<b>"Claim"</b>	The process set out in Article 5.2.
<b>"Landing Page"</b>	<a href="https://cz.yamaha.com/cs/musical-instruments/brass-woodwinds/explore/dorico/index.html">https://cz.yamaha.com/cs/musical-instruments/brass-woodwinds/explore/dorico/index.html</a>
<b>"Non-authorized Dealer"</b>	A dealer not authorized by the Promoter to sell its products that can benefit from this Promotion.
<b>"Participant"</b>	The requirements of an individual to participate in this Promotion set out in Article 3.1.
<b>"Promoter"</b>	Yamaha Music Europe GmbH, Siemensstraße 22-34 in 25462 Rellingen, Germany.
<b>"Promotion"</b>	DORICO EXTENDED TRIAL BY YAMAHA
<b>"Promotion Product(s)"</b>	The products set out in Schedule 1.
<b>"Promotion Period"</b>	The period of time between the Promotion Start Date and Promotion End Date in which the Promotion Product must be purchased, as set out in Schedule 2.
<b>"Promotion End Date"</b>	The end of the Promotion Period as set out in Schedule 2.
<b>"Promotion Start Date"</b>	The start of the Promotion Period as set out in Schedule 2.
<b>"Proof of Purchase"</b>	The receipt requirements as set out in Article 5.4.
<b>"Standard Currency"</b>	Euros (€).
<b>"Terms"</b>	The Terms and Conditions as specified in this document and amended from time to time.
<b>"Territory"</b>	The European Economic Area, United Kingdom and Switzerland.

## **ARTICLE 2 - THE PROMOTER AND THESE TERMS**

2.1. The Promoter reserves the right to cancel, amend, modify unilaterally or withdraw this Promotion at any time in its own sole discretion without any liability.

2.2. By participating in this Promotion, Participants agree that they have read, understood, accepted and will comply with these Terms.

## **ARTICLE 3 - ELIGIBILITY**

3.1. In order to be a Participant in this Promotion you must be a resident within the Territory, aged 18 or over and have purchased a Promotion Product in accordance with these Terms.

3.2. Participants are not eligible for the Promotion if they are listed below or if they are employees, or family members of employees of:

- 3.2.1 the Promoter;
- 3.2.2 the Promoter's subsidiary companies;
- 3.2.3 the Authorized Dealers;
- 3.2.4 any agent of those listed in Article 3.2.1-3.2.3; and
- 3.2.5 any other parties directly involved with this Promotion.

3.3. The Promotion is only open to Participants that have purchased a Promotion Product during the Promotion Period, in accordance with these Terms.

3.4. The Promoter reserves the right to verify the eligibility of Participants and/or to exclude Participants at its sole discretion at any time for any reason. Resellers and Authorized Dealers may not submit Claims on behalf of their customers.

## **ARTICLE 4 – HOW TO PARTICIPATE**

4.1. The Promoter is offering a Promotion whereby Participants will be eligible to claim the corresponding Product Reward shown in Schedule 1 when they purchase a Promotion Product set out in Schedule 1, from an Authorized Dealer, subject to full compliance with these Terms.

4.2. The Promotion is not available on any second hand, refurbished, reconditioned stock or for the products purchased from a Non-authorized Dealer.

4.3. The Participant must purchase the Promotion Product online or in-store from an Authorized Dealer located in the Territory to participate in this Promotion.

4.4. The purchase of the Promotion Product must take place during the Promotion Period as set out in Schedule 2. The Claim for the Product Reward must take place by the last day to apply for the Promotion corresponding to the applicable Promotion Product, as set out in Schedule 2.

## **ARTICLE 5 - CLAIMS**

5.1. A maximum of one (1) Promotion Product can be claimed per residential household and per Yamaha Music Connect account.

5.2 In order to participate in the Promotion and to be eligible to receive the relevant Product Reward, Participants must register their qualifying Promotion Product via the Landing Page and/or campaign materials during the Promotion Period. Participants without a personal Yamaha Music Connect account must first correctly register for a Yamaha Music Connect account via the Landing Page during the Promotion Period. After registering, Participants shall verify their account by clicking the link in the verification email sent to the email address provided during registration.

Once logged into Yamaha Music Connect, Participants must register the qualifying Promotion Product in the “Products and Services” area of their personal Yamaha Music Connect account. After successful product registration, a “Claim Dorico” button will appear next to the registered product. By clicking the “Claim Dorico” button, a unique Dorico software licence code (“Participation Code”) will be generated for the Participant.

By clicking the “Claim Dorico” button again, the Participant will be directed to the Dorico landing page on the Steinberg website, where Participants are required to: (1) create or log into a Steinberg ID account, (2) download the Steinberg Download Manager, (3) redeem the Participation Code, (4) download and install the Dorico software, and (5) activate the 120-day free trial in accordance with the instructions provided on the Steinberg website (together the “Claim”).

Participants already registered with Yamaha Music Connect who register their qualifying Promotion Product during the Promotion Period will also receive access to the “Claim Dorico” button and Participation Code within their Yamaha Music Connect account. In such case, the Claim must be completed by following the steps described above.

5.3 Each Claim is limited to a single use and cannot be used in conjunction with any other promotional offer against the Promotion Products stated in Schedule 1.

5.4 The Claim must include the serial number and product model of the Promotion Product, which are mandatory and may be used for validation. Each Claim is limited to one unique Yamaha Music Connect account per person (one email address) and only one Participation Code may be redeemed per registered Promotion Product and customer.

5.5 In the event that the Participant returns or exchanges the Promotion Product to the Authorized Dealer, the Participant will not be entitled to the Product Reward and any claim will be thereafter dismissed. For the avoidance of doubt this article does not prohibit in any way the Participant's right to exercise their applicable statutory or warranty rights.

5.6 The Product Reward is non-transferable, subject to availability, and cannot be exchanged for cash or other products.

5.7 The Product Reward will only be available following purchase, upon successful completion of the Claim by the Participant, and satisfactory claim validation by the Promoter.

5.8 In the event of unforeseen circumstances, the Promoter may substitute a Product Reward with another Product Reward of equivalent value at its own discretion.

## **ARTICLE 6 - DATA**

6.1 Upon submitting the Claim, the Participant will provide personal data such as name, address, etc., which is stored and processed by the Promoter and for the purpose of administering this promotion.

6.3 All personal information will be processed by the Promoter only in connection with the management of this Promotion including the provision of information to third parties designated to administer the

Promotion. This also includes the transfer of the data necessary for redeeming the Steinberg code, as the code will be redeemed on Steinberg's website. In as far as our third-party providers process your personal data, we will require them to adhere to the applicable data protection laws.

## **ARTICLE 7 - DISCLAIMER**

7.1 No responsibility will be accepted for Claims lost, delayed or for those Claims not received by the last day to apply for the Promotion.

7.2 Claims will be disqualified if incomplete, illegible, or if the Participant does not satisfy Article 3. It is the Participant's responsibility to ensure that sufficient details are provided for Claims to be processed.

7.3 The Promoter is not liable for any costs incurred by the Participant relating to the Promotion.

7.4 The Promoter shall not be liable for any delayed Claims of any nature regarding this Promotion.

7.5 The Promoter shall not be liable for any failure to fulfil this offer where such failure is caused by any supervening circumstances amounting to force majeure or third party fault (being beyond the Promoter's reasonable control) and/or events which, without the fault of either party, render performance impossible or incapable of satisfactory execution.

7.6 The Promoter, in its sole discretion, reserves the right to reject any Claim that it deems to not comply with these Terms.

7.7 The Promoter has the right to request reimbursement of the Product Reward for the returned, exchanged, or cancelled Promotion Product purchases.

7.8 The Product Rewards for Promotion Products listed in Schedule 1 are fixed and not dependent on the sale prices set by Authorized Dealers, who determine their own prices independently. The Product Rewards cannot be exchanged for products or alternative rewards.

7.9 If any provision of these Terms should be deemed invalid in whole or in part, this does not affect the validity of the remaining provisions. An ineffective provision shall be replaced by a provision which is legally permissible, and which comes closest to the provision deemed invalid, in terms of content.

## **ARTICLE 8 - JURISDICTION**

These Terms are governed by the laws of Germany. In the event of conflict between German law and the consumer laws of the country in which the Promotion Products were purchased, the latter will take precedence. The Terms are subject to the exclusive jurisdiction of the courts of Germany.
