

## TERMS AND CONDITIONS FOR THE PROMOTION – 3 MONTHS ACCESS TO FLOWKEY PREMIUM

## ARTICLE 4 – HOW TO PARTICIPATE

4.1 The promotion is open to participants who purchase a **qualified product**. The qualified product must be purchased within the promotion period.

4.2 **Promotion period:** The promotion campaign will continue until further notice.

4.3 The date of purchase shall be the invoice date of the purchase receipt, or in the case of orders placed online, the order date confirmed by the dealer.

4.4 The promotion is not available on any second hand, refurbished or reconditioned stock.

4.7 Upon successful registration Yamaha will deliver a specific code for a three-month premium access to flowkey (DAC). At the end of the 3-month period, if the participant does not choose to upgrade his or her membership, the membership will automatically revert to the free Basic membership, with limited access to flowkey content.

4.8 To redeem the code the participant needs to sign up for an account on <https://www.flowkey.com/> and enter the DAC. Internet access and a suitable computer/laptop (PC/MAC), iOS devices (iPhone, iPad) or Android-based tablet device (not supplied) is required to use this offer.

4.9 The DAC must be activated within 6 months of the date when the participant’s qualified product was registered. Promotional codes not redeemed within 1 year of receipt will expire.

4.10 Each DAC can be redeemed only once. The DAC cannot be exchanged for cash.
